MEALS ARE SERVED FROM 11 CONGREGATE SITES ACROSS SAN DIEGO COUNTY INCLUDING OUR GARY & MARY WEST SENIOR WELLNESS CENTER, AND DELIVERED DIRECTLY TO OVER 600 HOMEBOUND SENIORS A DAY.

THE TRANSITIONAL HOUSING PROGRAM HELPS HOMELESS SENIORS GET OFF THE STREETS BY PROVIDING TRANSITIONAL HOUSING AND SUPPORTIVE SERVICES AS A DIRECT STEPPING STONE TO PERMANENT AFFORDABLE HOUSING. CASE MANAGERS HELP CLIENTS APPLY FOR ENTITLEMENTS, SAVE AND BUDGET THEIR MONEY, ACCESS HEALTH AND COMMUNITY SERVICES, PROVIDE LIFE SKILLS TRAINING, AND MAKE REGULAR IN-UNIT CHECK-INS.
